MEETING FOR BUSINESS

AUGUST 26, 2012

HELD at BRISTOL MONTHLY MEETING

Friends gathered around the appointed hour of 1:00 PM and settled into a period of worship.

Agenda reviewed and accepted.

Roll Call of Meetings:

Bristol: 4, Buckingham: 1, Doylestown:3, Fallsington: 2, LehighValley: 2, Makefield: 3, Middletown: 3, Newtown: 4, Plumstead: 0, Quakertown NJ: 2, Solebury: 1, Southampton: 2, Wrightstown: 2, Yardley: 1

Minutes approved with corrections noted

Stories of Vitality and Growth were offered by Wrightstown, Doylestown, Lehigh Valley and Middletown Meetings.

Quarter Coordinator's Report given by Holly Olson (Middletown). (Complete written report available). She prefaced her report with the suggestion that Annual Reports presented to Quarterly Meeting should also be included in meeting monthly newsletters.

- Special importance placed on the Aging Workshop, called “Spirit and the Final Third of Life: A Friends Approach”, that will be held on November third at Buckingham Meeting House and School. All present were urged to publicize this program at their monthly meeting.
- Outreach listed the various festivals throughout Bucks County that will have a Quaker presences.

The Clerk provided an opportunity for Friends to discuss their experience at Annual Sessions after a quick poll indicated that almost all in attendance at BQM had also attended Annual Sessions.

Buckingham MM Annual Report was given by Bethann Morgan, Co-Clerk. Highlighted was the excitement of receiving three new applications for membership, the enjoyment of working on Snipes Farm, and the success of "Games Night" on Saturday evenings.

Southampton MM Annual Report was given by Carolyn Eckel, Clerk. Currently first day meeting for worship is held on the fourth Sunday of the month. Weekly evening Meeting for Worship is held on Tuesday. The Meetinghouse is also used by a number of other groups. The work that the Meeting has done to continue with so few active members was recognized.

Solebury MM Annual Report was given by John Kellogg, Clerk. Betsy Cotton (FDS Coordinator) has been doing a wonderful job preparing lesson plans for young Friends. First Day Adult Discussion has been focusing on Geoffrey Durham's book "The Spirit of Quakers". Attendance overall has been very steady without significant increases or decreases.

Amy Ward Brimmer provided an update of the changes to applying to the **Friends Education Fund**. Administration of the Fund has been transferred from the Yearly Meeting to Friends Council on Education. This year, forty-four children in Bucks Quarter are receiving assistance from this fund.

Treasurer's Report: Tim Dwyer (Bristol MM), Treasurer, and Betsy Bayardi (Wrightstown MM), Clerk of Budget and Nominating, gave report. Betsy reported that we are in good shape with \$21,000 in checking account at the end of the fiscal year. All commitments were met and all bills were paid. Determining the correct amount of money to be held in reserve was discussed. Budget and Nominating committee takes into account the changing economic and market situations in establishing reserve amount desired.

Proposal: A Fivefold Path to Peace. Bethann Morgan reported for the Ad Hoc Group formed at last Quarterly session. It has considered the proposal created by Paul Kester and titled Conflict: Causes, Consequences and Cures Peace Proposal and reported that the group supports it. She then read the proposal which included the Fivefold Path to Harmony. The Clerk asked for response from the Meeting. Interim Meeting is going to need clear instructions as to what they are supposed to do. It was suggested that the minute be referred to the PYM Standing Committee on Peace and Social Concerns and then forwarded to Interim Meeting with their suggestion for action to be taken. Friends supported Paul Kester to carry forward his Peace Proposal.

Wrightstown MM Annual Report given by Leo Fitzpatrick, Clerk. He noted that three dear members passed away this year. Renovation of the Meetinghouse is done. Nursery School director Kate Lightfoot is recruiting for the Nursery School and still has some openings. He also reported that the Outreach Committee is addressing the downturn in attendance in First Day School and Worship.

Middletown MM (Middletown Friends Meeting at Langhorne) Annual Report was given by Bill Daly. Report focused on strengthening meeting for worship and highlighted the variety of programs that are being held at the Meetinghouse.

Yardley MM Annual Report was not read.

Quaker School at Horsham Annual Report was given by Ruth Joray. Small specialized schools are facing many difficulties in the current economic climate and the school has had to re-budget due to declining enrollment. Mission of school is a wonderful meld of the values of Quakerism and dealing with the Learning Disabled. Some new concepts being introduced are therapy dogs. School should be recommended to any parents in the Quarter who have special needs students. The school needs additional Board members with experience in Marketing and Development.

Minute on Separation of Church and State: The following minute, approved by Lehigh Valley Meeting for Business of August 5, 2012, and HR 771 which it refers to, was read by David Rose.

MINUTE 1: Lehigh Valley Quakers call for a vote on HR 771 declaring 2012 "Year of Religious Diversity in Pennsylvania". Philadelphia Yearly Meeting of the Religious Society of Friends (Quakers) has a three hundred and thirty two year history that goes back to the founding of Pennsylvania by William Penn, a Quaker. Lehigh Valley Monthly Meeting of the Religious Society of Friends considers an important legacy that William Penn left is the value that he placed on religious toleration and freedom from any dictates by government in matters of personal faith. This value is still expressed in the Pennsylvania Constitution Declaration of Rights which states: "no preference shall be given by law to any religious establishment or modes of worship". Pennsylvania, and the United States, have greatly benefitted from our heritage of religious toleration and freedom of conscience. Lehigh Valley Monthly Meeting of the Religious Society of Friends therefore supports House Resolution 771 declaring 2012 "the Year of Religious Diversity", introduced by Representative Mark B. Cohen on June 13, 2012 and referred to the House Committee on State Government. We urge that it be release from committee and voted on its adoption by the House.

David Rose indicated that the process upon approval of the minute by Bucks Quarterly Meeting would be to have it considered by PYM Interim Meeting with the intention of having the approved minute forwarded to the Pennsylvania Council of Churches, Pennsylvania House of Representatives leaderships, sponsors and cosponsors of HR 771, and members of the Committee on State Government. Meeting approved minute as presented and recommended its consideration by Interim Meeting.

Bucks Food for Friends: Holly provided an update on the program that started three years ago and now has seventeen churches involved. The level of cooperation and giving is outstanding with additional volunteers always appreciated.

After Announcements, **Meeting ended** with a period of silence at 3:55 pm.
